4. POLICE REPORT; A full detailed statistic report was made available.

- Overnight 6-7 July, a garden shed was broken into in the Dryden area and an industrial strimmer was stolen, valued at £700. It is described as being in good condition with a grey head and grey cord.
- Overnight 7-8 July, lead was stolen from the roof of the Loanhead Social Work building.
- On the evening of 8 July, an air conditioning unit, valued at over £2000, was stolen from a garden in Dryden Terrace. This was recovered in a house nearby and a male aged 41 years and female aged 37 years have been reported for this offence.
- Overnight 13-14 July, a quantity of metal valued at £7,400 was stolen from the new Asda site at Straiton.
- Between 15-22 July, 3 bicycles were mistakenly left within a garden in the Mayburn area after a garage clear out, valued at £950. These were subsequently stolen and are described as:
