The Chair welcomed everyone to the meeting.

1. **Apologies** – Daya Feldwick, David Temple, Councillors Winchester and Parry.
2. **Chairman’s Report.** Pat Kenny reported that the Community Council had another busy year dealing with correspondence and meetings re planning and licence applications. He welcomed the new development of rented housing on the former Library HQ site and the possibility of affordable homes on the Mayburn House site. On-going topics were proposed changes in flight routes from Edinburgh Airport.
3. **Financial Report** – John Thomson reported that the current bank balance was £1454.51. We had spent £295.48 of the annual £300 grant. The financial report was approved, proposed by Gina Temple, seconded by Annabel Hamilton.
