## 3. PREVIOUS MINUTE

The minutes of the meeting held on 13<sup>th</sup> November 2012 having been distributed and read, were approved;

4. POLICE REPORT; A full detailed statistic report was made available.

#### **Incidents of note**

- On 3 November, a window at the Card Warehouse, Clerk Street was smashed.
- Sometime between 27 October and 14 November, a petrol strimmer was stolen from a shed at a property in Mavisbank.
- Sometime between 9 November and 14 November, a disused garage premises on Clerk Street was broken into and a quantity of electric cable was stolen. A number of car tyres were also dumped at the premises.
- On 14 November, six males caused a disturbance and assaulted a member of staff at Sainsburys. The culprits are described as 18-20 years of age, English accents, wearing dark clothing.
- On 22 November, a person has attempted to gain entry to a dwelling house in Mayburn Vale by sliding open an internal glass door after opening a rear insecure door. The occupant of the house heard a noise and when investigating the matter, saw that both doors were lying open. No person seen at the property by complainer. It was established that no property stolen.
- On 23 November, a panel of the rear patio door of a dwelling house in The Loan was smashed by unknown means. The occupant of the property was within at the time of the incident but did not see any person committing crime.
- Overnight 26 27 November, an attempt was made to force entry to the shop premises of Day to Day Express, Mayburn Avenue. Persons attempted to force open the metal shutter of the rear door of the premises but no access was gained.
- Overnight 26 27 November, an attempt was made to force entry into a garden shed in Wheatfield Walk. Persons had forced padlock and hasp using bodily pressure but no entry was gained.
- Overnight 28 29 November, a Vauxhall Corsa parked in Burnbank Crescent, was maliciously damaged by a person who poured paint stripper over the bodywork of the vehicle causing £500 worth of damage.

#### Other matters

Due to the number of break-ins to sheds and other similar incidents, officers have been carrying out both hi-visibility and plain clothes patrols during the hours of darkness.

The Christmas initiative is again running at Straiton Retail Park this year during the month of December. This is to provide a hivisibility presence in order to deter shoplifters as this increases dramatically at this time of year. This initiative is resourced using Community Officers from Penicuik, Loanhead and Bonnyrigg and has proven successful in previous years. Policing resources in Loanhead and the surrounding areas will not be affected by this initiative.
